

## ***Safety & Rules***

1. **CANCELLATION POLICY & NON-REFUNDABLE DEPOSIT** 50% deposit required to reserve bus. Balance is paid to driver (cash) on day of event. Non-refundable deposit if the booking is cancelled.
2. **\$100.00 CLEANING FEE** will be payable to driver if the bus is **COMPLETELY THRASHED** outside of an average cleaning. **NO GUM, FOOD, SNACKS or GEL SHOTS ALLOWED ON THE BUS.**
3. **\$100.00 VOMIT FEE** will be payable to driver if any passenger VOMITS in or on the bus.
4. **NO MULTIPLE PICK UPS OR DROP OFFS** no exceptions unless specified in the contract.
5. **SERVICES** We do not offer cruising around or bar hopping services. Driver will take you to your destinations detailed in the contract. Driving around during the run is a service not offered.
6. **ADDITIONAL NON-SCHEDULED HOURS** \$175 per hour pay to driver at the start of every hour.
7. **ADDITIONAL PASSENGERS** added during the trip, who were **NOT** part of the original group, will be at the discretion of the driver not to exceed 20 passengers.
8. **POSSESSION OR USE OF ILLEGAL DRUGS** by anyone is prohibited in the limo bus. If the driver observes paraphernalia during the run, the driver will terminate the run & you will receive no refund.
9. **PARTY BUS KING** reserves the right to eject any individual(s) whom they deem to be disruptive, intoxicated, pose a safety threat to themselves or to others or deemed to be using an illegal substance.
10. **PARTY BUS KING** gives the sole judgment to the driver, if he determines that the behavior of you or your guests is out of control, unsafe ,illegal, dangerous or irresponsible to lives and/or property; driver will terminate the run & order all occupants out of the bus. He may or may not issue a warning before taking such action. If this occurs, you will not receive a refund.
11. **PARTY BUS KING** will not tolerate any actions such as fighting, violence, damage to the bus equipment or harassment toward the driver or anyone else in or around the bus. The driver reserves the right to terminate the run. The client will be responsible to find other transportation & forfeits full fare as a result.
12. **PERSONAL PROPERTY** Party Bus King is not responsible for any lost or stolen property during the run or property left after the run has ended.
13. **PARTY BUS KING** is not responsible for injuries or accidents in & around the bus. Alcohol impairs motor skills, balance & judgement. Clients are asked to remain seated while the bus is in motion. Move about at your own risk. Use of hand rails throughout the bus is recommended at all times.
14. **AGREEMENT** Signing this contract & any persons participating in the ride, all agree that **PARTY BUS KING** are not responsible for any claims for injuries, loss, damage, death, liability, criminal or civil litigation for the participating individual arising out of or relating to the run in the limo bus.
